Transportation options and directions:

If you are arriving by train or bus, the church is directly opposite the Harrisburg Amtrak station. This is an intermodal station, also serving as Harrisburg's Greyhound and Trailways bus station. There is a small walking path that puts you directly across from the office entrance at the corner of the alley between the Alva Hotel (19 South 4th St.) and the church. This door will be open for those attending the meeting. At this door there will be information about another door that provides a ramp entrance.

According to the current Amtrak schedule, if you are arriving from Newark, Trenton, Philadelphia, etc., train #663 arrives in Harrisburg at 12:45 p.m. Train #672 departs from Harrisburg at 5:05 p.m. for Philadelphia, Trenton, Newark, etc. Check Amtrak schedule closer to the event for any changes.

If you are arriving from Pittsburgh, Altoona, etc., train #42 arrives at 12:53 p.m. However, there is no return train till Sunday at 2:36 pm. Greyhound provides service to Pittsburgh and eight (!) intermediate stops, leaving Harrisburg at 6:10 p.m., arriving Pittsburgh at 12:55 a.m. on March 10. Megabus has service on March 9 leaving Pittsburgh at 6:50 a.m., arriving in Harrisburg at 12:30 p.m., but be aware that the Megabus stop is a considerable distance from downtown Harrisburg, and taxi service can be very hard to obtain. There would be no return Megabus service till the next day (Sunday).

If you are driving, park at the Chestnut St. Garage (322-26 Chestnut St.), which is located at Chestnut and 4th St., a very short distance from the church. Payment for parking at this garage has now been automated. You will be given a second ticket at the church to be used in addition to the one that you get at the garage. Since we need to let the church know how many of these tickets to have on hand, please indicate on the form whether you will be using parking validation, and please register by February 27.

Enter the church at the main doors, which lead directly to the fellowship hall. There is also a ramp entrance on that side of the church.
